Rules:

1. **Entry deadline is February 26, 2024.** Winners will be notified after judging. Contest winners will be officially announced via the Oconee Valley Healthcare Facebook page.
2. Children no older than 17 of the OVH Community (patients and non-patients) are eligible.
3. The child must produce the artwork without assistance from anyone else. The entry must be original and not a copy of another work.
4. Artwork can be a drawing, painting, collage or other two-dimensional piece. Artwork must be between 8" x 10" to 18" x 24". Please do not use notebook paper or colored construction paper as the background.
5. The subject of the art piece can be freely chosen by the artist but must:
 - a. Be age appropriate for a Pediatric Medical Office
 - b. Not be political, obscene, offensive, etc.

By entering the contest, each contestant and his or her parent/guardian warrant that the submission is the contestant's original work.
